
The Regional Municipality of Durham and the Regional Municipality of York submitted the revised Air Emissions Monitoring Plan (AEMP) on February 11, 2013, following extensive consultation with Ministry of the Environment (MOE) staff on various technical aspects of the AEMP. Approval to submit the revised plan was received from Central Region as indicated in the enclosure dated February 1, 2013.

At the February 12, 2013, Energy from Waste Advisory Committee (EFWAC) meeting, a motion was passed to allow an additional review of the plan, in particular the revisions requested as a result of the consultation with the MOE. The MOE was advised of this additional review period by way of the attached document dated February 14, 2013.

The attached comment/response table summarizes the proponents' evaluation of the comments received from the EFWAC public representatives on February 28, 2013. The proponents feel some comments were previously submitted by members and addressed in the original comment/response table dated August 31, 2012. There were also some new comments related to the revisions requested by the MOE which provided guidance on future consultation to address changes or directed specific test methods contained in the Ontario Source Testing Code or other accepted agency (USEPA or Environment Canada).

Following our detailed review of the public submission, the proponents have determined that based the comments received, the AEMP submitted to the MOE on February 11, 2013, does not require any further revision. If you require additional information, please contact the undersigned.
