Tong C.E.O. and President Covanta Durham York Renewable Energy Ltd.</p> <p>2) You might like to access the following enlightening "YouTube" presentations.</p> <p>Part 1 http://youtu.be/thj5QQ342LE Part 2 http://youtu.be/nUlhnwmw21Zs</p> <p>3) As you are aware, Durham/York Region's Covanta Municipal Waste Incinerator, located in Clarington Ontario, will commence its operations in approximately six months from today.</p> <p>4) As you may also know, Environment Canada's five-year wind direction study conducted at Toronto's Pearson Airport, concludes that families living and working in Toronto, Ajax, Pickering, Whitby, Oshawa, and other communities will become exposed to incinerator emissions transported by winds from the East during substantial times in the year.</p> <p>For example, last week, according to the enclosed Weather Network print outs copied below show, Toronto experienced four days of easterly winds. In addition, the Weather Network reported that on one day, the cloud-ceiling layer was only 600 feet.</p> <p>For comparison purposes, the CN Tower is 553.33 metre or 1815.4 ft high.</p> <p>This means that tons of toxic emissions from the Clarington's smoke stack would be trapped between the ground level and the lower layer of clouds.</p> <p>These toxins would slowly drift towards Toronto.</p> <p>This also means that homes and buildings in your neighbourhood, with fewer than 40 floors, would be totally engulfed in toxins emitted from Clarington's municipal waste incinerator.</p>	Neg	<p>Please be advised that we have logged your email complaint dated October 11, 2013.</p> <p>In response to your questions, we would like to direct you to our project website where details of the project Environmental Assessment technical studies are posted for review, specifically the Human Health and Ecological Risk Assessment Technical Study Report : http://www.durhamyorkwaste.ca/pdfs/study/amended-ea-study-docs/Amended-HHERA-Report/Durham-York-HHERA-FINAL_style-guided_Dec-10_2009-rev.pdf</p> <p>These studies have demonstrated that there will be no adverse effects to human health or the environment.
